- Bruce Stettler, Schnecksville, asked if resolution could be worded to only allow non-working supervisors.
- Samantha Neas, Schnecksville, voiced her concern that by increasing the number of supervisors more could conceivably appoint themselves working supervisors that we currently have.
- Bruce Stettler, Schnecksville and Susan Travis, Slatington, both commented that candidates should be required to state their intentions of working or not during the campaign.
- Eric Neubauer, Coplay, asked how long is a supervisor's term.
- Donald Steffy, Coplay, thank the Board for taking this step to increase the Board membership. He feels it will provide a more representative government and he would like to dedicate this to the many residents, past and present, who advocated this move for the past 30 years.
