## **OLD BUSINESS:**

#### **REQUEST FOR TRAFFIC SIGNS**

The original request appeared before the Board on January 7, 2013 and was tabled. The Secretary had received a letter from Grace Ludwig requesting a four-way stop and school bus stop ahead signs at the intersection of Bellview and Fairview Roads. She feels the drivers cresting the hill do not have sufficient time to stop when encountering a school bus or children crossing the road. In the interim, the Parkland School District Transportation Department notified the Township that they have relocated the bus stop for Ms. Ludwig's children and neighboring children closer to her driveway. The Board decided not to take action on this issue.

## **REDUCTION OF LETTER OF CREDIT**

Weis Markets submitted a revised letter, dated January 24, 2013, requesting release of their Gasn-Go Improvements Letter of Credit. The original request, dated October 8, 2012, had been tabled. The revised letter requests release of the total Letter of Credit and asks that they be invoiced separately for the cost of the preemption equipment. General Planning Engineer Stephen Gitch, in a letter dated October 31, 2012 recommended release of the original request and stated all site improvements had been completed.

Upon motion by Steve Pany, seconded by Mark Hills, the Board authorized the Treasurer to invoice them for the preemption and authorized the release of the Improvements Letter of Credit for Weis Gas-n-Go pending receipt of payment and the installation of the compact car signs. - Ronald Roth, Rt. 309, Schnecksville, inquired about the cost to enact an ordinance. He encouraged the Board to create an ordinance to prohibit any airports or heliports within the township. He feels that creating an ordinance will be more cost effective than incurring legal fees to hear application for such facilities.
- Leonard Nuss, Coplay, asked if the airport on Peach Bottom Road was abandoned.
- Betty Shuster-Hanzlik, Hilton Road, Schnecksville, Asked the Board if there was a need for a heliport or airport. She feels such a facility is not conducive to the township's environment.
- Jeanene Bauer, Jordan Rd, Orefield, inquired about the status of the Jaindl land sewage treatment plant and what would be the route of conveyance from the Sand Spring sewage plant to the Levans Road plant.
- Harold Smith, Neffs, questioned the signs throughout the Neffs Valley Park.
- William Semmel, Settlers Ridge, Slatington, informed the Board of the conditions of the
  road in his development and the non-action of the developer to correct the issues. He also
  inquired about the possibility of the township completing the road and pulling the
  developer's bond.
