### REQUEST TO REDUCE SPEED ON MAUCH CHUNK ROAD

Upon motion by Ronald J. Heintzelman, seconded by Jerry Joseph, the Board authorized the Secretary to forward the letter from resident Richard Getz to PA DOT for further study. Mr. Getz is requesting the speed limit be reduced to 35 MPH on Mauch Chunk Road, through the village of Ruchsville, in an attempt to control the speed of traffic and to protect the residents who must cross the road to obtain their mail. The intent of this revision is to assure that future lots are graded and that driveways and swales are correctly installed in strict conformance as depicted on the approved grading plan. Upon motion by Ronald E. Stahley, seconded by Ronald J. Heintzelman, the Board authorized the Solicitor to proceed with the request to hold a public hearing to amend the Zoning Ordinance. ## **PENSION REQUIREMENT ESTIMATE FOR 2012**

Treasurer Brenda Norder presented an estimate of the minimum municipal obligation for the North Whitehall Township Retirement Plan for the year 2012 to be \$ 52,078.43. Income from State Pension Aid is projected to be \$ 72,688.25. A total estimate of \$ 124,766.68 is projected in pension expenses for budgetary figures.
