D & L TRAIL COVE ROAD TRAILHEAD PARKING PROBLEM

Robert Stiffler, Christopher Strohler and Scott Everett appeared before the Board to discuss the parking problems at the Treichler's Bridge D&L Trailhead. They requested the Board enact an ordinance and install signs prohibiting parking along sections of the road in that area. Other remediations to the parking problem were discussed.

- Mark Hills, River Rd., Laurys Station, noted examples of the parking problem near the trail head.
- Dan Nemeth, Clearview Rd., Coplay, inquired if a boat launch was allowed in that area.
- Tom Van Vreede, Church Drive, Coplay, voiced his concern for pedestrian safety if cars were allowed to cross the trail and that bikes are being ridden at high rates along the trail.

MANAGER'S REPORT

REQUEST FOR PAYMENT #4 IRT EXTENSION PROJECT

An application for payment of \$63,849.67 has been requested from Livengood Excavators for the work on the Ironton Rail Trail Phase 2 Extension Project. Upon motion by Steve Pany, seconded by Richard Celmer, the Board approved the payment application. Roll call: Richard Celmer - yes; Ronald J. Heintzelman - yes; Steve Pany – yes. There were no public comments on this item.

- Mr. Bartlett presented an update on the IRT construction.
- He announced there will be a second meeting in October. The October 19th meeting will be held for the purpose of 2016 budget discussions.
- Mr. Bartlett requested the Board authorize him to begin the purchasing process for a new street-sweeper on the state contract. The cost is \$249,975.00 and he proposed to lease it with a \$1.00 buy-out.

Heintzelman, seconded by Steve Pany, The Board authorized the Manager to proceed with the purchasing process for a new street-sweeper in order to receive it as early as possible for the 2016 season. - o Jeanene Bauer, Jordan Rd., Orefield, questioned if Supervisor Heintzelman had a conflict of interest by voting on this since he was also an employee.
- Jeff Barber, Manchester Place, Slatington, asked for details of the lease conditions and stated better rates may be obtained from the local banks.
