## WEIS GAS N' GO LAND DEVELOPMENT PRELIMINARY

Timothy Snyder, John Lerch, John Luciani, Jack O'Hara, Jim Preston, and Joseph Gurney presented the preliminary plan of the proposed Weis Land Development to the Board.

Discussion ensued on various topics including but not limited to: snow removal, dissatisfaction with the traffic flow, traffic in front of the kiosk, pedestrian safety, hydrant placement, and fuel delivery plans.

Upon motion by Ronald E. Stahley, seconded by Ronald J. Heintzelman, the Plan was tabled pending further review by the developer and township consultants and staff.

Roll call: Jerry Joseph - yes; Ronald E. Stahley - yes; Ronald J. Heintzelman - yes.

- Mark Hills, Laurys Station, stated that he felt Weis should have to conform to parking lot standards the same as Wal-Mart had to conform.
- Ronald Roth, Schnecksville, voiced concerns regarding the fuel delivery truck driving in front of the store and pedestrian safety. He also questioned if Jay King's name was on the plan.
- Leonard Nuss, Coplay, noted concern with the tanker fueling area and over-sized cars parked in the compact spaces sticking out in the driving lane.
- Ricky Harring, Schnecksville, asked why this wasn't built in 2005 when it was first proposed and can fuel delivery be mandated to occur at off-peak hours.
- Ronald Roth, Schnecksville, inquired about the township's liability if this plan is approved and someone is hurt or killed by the delivery truck.
- Ricky Harring, Schnecksville, commented that fuel delivery would be impossible during holidays with increased traffic in the parking lot.
- Charles Horwith, Schnecksville, inquired about the tanker's registration with DEP and if Jay King's name is on the plan as the property owner.
- Mark Hills, Laurys Station, asked how many spaces would be blocked when the fuel is being delivered.
- Ronald Roth, Schnecksville, asked what was the vote count for the Planning Commission members.
- Ricky Harring, Schnecksville, commented that the only way this plan would work is if Weis came up with more square footage of property.

## WELL ISOLATION DISTANCE EXEMPTION & GROUNDWATER STUDY WAIVER REQUEST

Sewage Enforcement Officer, Scott Bieber submitted a letter dated May 11, 2011, to the Board, recommending that the request for the well isolation distance exemption and groundwater study waiver for Robert & Jodie Stetz, 4441 Mauch Chunk Rd, Coplay, be granted.
