MANAGERS REPORT CONT'D

- Junior First Responder Camp The sold out weeklong camp began July 7th for children ages 10-15. The program showcases great community cooperation between all four fire companies and teaches youth about firefighting and prevention habits through games, lectures, and activities. The kids learn some CPR and get to try on some fire gear. This is also a great recruitment opportunity to hopefully get the next generation interested in volunteering at their local fire company.
- Summer Playground Program Overall, there are 230 children enrolled in this year's program.
- Farmland Preservation The Township and Lehigh County recently preserved the Muth farm along Coplay Creek Road. This 77.49 acres adjoins the previously preserved Semmel Farm. A special thanks to the Muth Family and Lehigh County for helping to preserve this critical farm.
- Pickleball Courts at Independence The pickleball courts at Independence are nearing completion and be open to the public. The color coating is complete, and the fence should be completed by the end of the week. There will still be some landscaping and seating amenities installed at a later date.
- Tannery Swale The swale restoration work that intersects Tannery Road is currently underway. This project helps to reduce sediment into our waterways and gives us significant credits to be used for our MS4 programs.
- Flock Cameras Over the next month, you may notice 9 cameras getting installed. As a
 reminder, these cameras are not being used for everyday speeding or unregistered
 vehicles. These cameras are being used for serious criminal violations and have been
 proving effective in many jurisdictions. The Township is participating in a pilot program
 to gather data. In October, we will be running a golf tournament to help offset the cost of
 these cameras and get them permanently installed. Overall, these will help make NWT
 a safer place.
- The new Swap Loader truck has finally been received! This is the truck we have been waiting almost 3 years for. The truck will be used for flushing storm and sanitary sewer systems and leaf collection throughout the township.

- Luke Walters, N 22nd St., South Whitehall Township, Sue McGory, Skytop Court, Lowhill Township, Joann Yurconic, Snyders Church Rd., Bath, Joshua Hahn, Mountain View Dr., Northampton County, Andrea Valarde, Manor Rd., Schnecksville, Lawrence Balsamy, Balsalm Ct., Center Valley, Kelly Sullivan, Buck Run, Schnecksville, Donna Schappell, Stahley Dr., Schnecksville, David Bollinger, Walnut Dr., Schnecksville, Ed Noga, Oakhill Rd., Emmaus, and Ashley Schappell, North Whitehall Township, expressed concern about the implications and reasoning behind the Zoning Hearing Board's decision in the case of Gene Weierbach, citing potential impacts on township zoning integrity and future land use precedent.
