RESOLUTION 05-12-25 PURCHASING COORIDNATOR BUDGET TRANSFER

Upon motion by Al Geosits, seconded by Dennis Klusaritz, the Board approved Resolution 05-12-25 approving reorganization of full time Receptionist position to Purchasing Coordinator and approving an intrafund budget transfer of \$4,800.00 in the General Fund. RESOLUTION 05-12-25A LIQUIDATION/REINVESTMENT OF POOLED INVESTMENT

Upon motion by Ronald J. Heintzelman, seconded by Al Geosits, the Board approved Resolution 05-12-25A authorizing the liquidation of Pooled Investment with Neffs National Bank and the reinvestment of such funds into the Government Transparency Series (GTS) Fund of the Pennsylvania School District Liquid Asset Fund (PSDLAF) in the amount of \$6,578,313.00. - Jeanene Bauer, Jordan Rd., Orefield, expressed concern that the packet of information presented on this fund did not include a disclosure about fees. She asked the Board to delay making a decision on this agenda item until the fee disclosure is provided.
- Kathy Crawford, Briarwood Dr., Coplay, asked Ken how GTS was able to offer such low fees and high rates.
- Bud Bauer, asked for clarification on what type of clientele is permitted to participate in this program.
- Rich Semmel, Clearview Rd., Coplay, suggested delaying investing the total sum of the Township's current investment account, and instead start with a smaller amount.
- Brian Horwith, Spring St., Coplay, expressed that he felt the vetting of the program could have been more in depth.

- Township Building Renovation Report provided verbally by John Carson of the Pelorus Group.
- Summer Playground Program The Ironton Elementary site is full and has a waiting list, and there are only 27 available spots at the Schnecksville Elementary site. In total, there are already 223 children signed up for the program.
- Fire Code Administrator The Fire Code Administrator position has been advertised on the township website, InDeed, PennBOC, PSATS, and social media. Staff have interviewed the top four (4) of the twelve (12) total candidates and will be making a formal recommendation to the BOS on June 2nd.
- Open Space Action Plan We received over 1,075 surveys. These results will help the Township prioritize preservation goals of farmland and open space for the foreseeable future. The consultant will be presenting these results to the Farmland Preservation Board at their July 10 meeting.
- Pickleball Courts at Independence Park The pickleball courts at Independence Park are
 progressing nicely. The fencing and paving were supposed to start this week, but the
 weather appears that it will not cooperate. This will likely occur next week, but we still hope
 to have these courts ready for play by mid-summer.

MANAGERS REPORT CONT'D

- IRT Portland Street Trailhead Staff recently received a \$5,000 Lehigh Valley Greenways Mini-Grant to beautify the Portland Street Trailhead. Improvements will include a new timber guiderail between the parking area and trail. This project will be completed in-house this summer or fall.
- Flock Camera System The flock camera system program continues to move in the right direction. Currently, we are awaiting the installation of nine (9) cameras which will be utilized on a 60-day trial basis. The trial basis will likely start sometime in July and will immediately begin dispatching data to the PSP when the cameras get a hit on an identified vehicle. As you may already know, the Township is conducting a golf tournament to help fund the initial and annual expense of this system. This golf tournament will take place on October 10th. More information can be found on our website home page.
- Oracle Our new financial enterprise system went live today. This new financial
 management system will simplify reporting for the Finance department and will also create
 increased checks and balances for all purchases happening within the Township. This
 software will also simplify requisitions, purchase orders, vendor communication, and
 budgeting. This has been a big undertaking and Seth deserves a lot of credit for staying
 diligent and patient throughout the process.
 - Jenny Krumrine, Coplay Creek Rd., Schnecksville, inquired about the zoning ordinance update that has been ongoing. She asked if we compare our ordinances to other municipalities and what was the driving force behind making this change.
 - Rich Semmel, Clearview Rd., Coplay, encouraged residents to bring their concerns or questions about the update to the next Planning Commission/Board of Supervisors joint work shop meeting.
